- I.** The name of the Company is “**COSMIC CRF LIMITED**”
- II.** The Registered Office of the Company will be situated in the state of West Bengal.
- III.** The Objects of the Company to be pursued on its incorporation are :

**III (A) THE OBJECTS TO BE PURSUED BY THE COMPANY ON ITS INCORPORATION ARE**

1. To manufacture and trade railway components, cold rolled formed sections, forged items, non-forged items, steel plates and coils, tubes, and any other allied components and products for the railways, wagons, locomotive, bogies, automobiles, passenger coach, metro rail and defence equipment.
2. To manufacture, produce, process, formulate, buy, sell, Import, export, trade or otherwise deal in ferrous and non-ferrous metals, and non-ferrous powders including alloy steel, Ferro alloys, Ferro-chrome, Ferro-ferre-manganese, silicon. Carbide, Calcium carbide, Ferro-silicon magnesium, titanium. Btantonlie powder, tungsten, vanadium and lime stone powder strontium, terra-silicon zirconium, ferro-aluminum refraction, silicon manganese. Chemicals, minerals, pig iron, wrought iron, steel converters, rolled steel, stainless steel, makers, miners, Smelters, engineers. Iron and sleet foundries, sponge iron, steel-castings, chrome alloys, silicon alloys, manganese alloys, aluminium thermic alloys.
3. To produce, manufacture, process, refine, import, export, purchase, sell and lo mine from earth generally to deal in and to act as agents, stockists, distributors, Retailers, wholesalers. Indenture, packers, 'movers, agents, sub-agents, merchants, consignors, jobbers, brokers, concessionaries and suppliers of iron sleet, refractors, Ferro-silicon, Ferro-manganese. Ferro-chrome. Calcium carbide. Ferro vanadium, Ferric oxide, other Chemicals and preparations connected with the aforesaid products and in connection therewith to take on lease or acquire erect, construct, establish work operate arid main- lain factories, quarries, mines, workshops, processing plants and other works.

**III. (B) MATTERS WHICH ARE NECESSARY FOR FURTHERANCE OF THE OBJECTS SPECIFIED IN CLAUSE III (A) ARE**

1. To purchase, acquire, build, construct, alter, maintain, enlarge, equip, pull down, remove to replace, and manage and control any buildings, offices, factories, mills, laboratories, shops, machinery equipments, apparatus, engines, roadways, trolley ways, reservoirs, water-courses, electric work, renovate and decorate and other works and conveniences, which may seem calculated directly or indirectly to advance the main objects of the company, and to join with any other person or body corporate in doing any of these things.
2. To import and purchase any machinery, implement, apparatus equipments, materials, articles and stores and to do all things for attaining the main objects of company.
3. To purchase, or take tenancy or in exchange, hire, take options over or otherwise acquire any estate or interest whatsoever and to hold, develop, plan, improve work, cultivate, deal with and turn to account

concessions, grants, decrees, licenses, privileges, claims, options, property, real or personal, or rights of powers of any kind which may appear to be necessary and convenient for attaining the main objects of the company and to purchase, charter, hire, build or otherwise acquire crafts, cars, vans or vehicles of any description and to employ the same in the business of company.

4. To acquire from any person, firm or body corporate or unincorporated, whether in India or elsewhere, technical information, know-how, processes, engineering and operating data, plans, layouts and blue prints useful for the design, erection and operation of plants, machineries or apparatus required for attaining the main objects of the company and to acquire any grant or license and other rights and benefits in connection therewith.

5. To grant allowances, salaries, gratuities, pensions and bonuses to employees or ex-employees of the company or dependents of such persons, and to support and to subscribe to charitable or other institutions, and to create and subscribe to any provident or benefit fund for the employees of the company or of any other company under the secretary-ship or management of the company.

6. To sell, exchange, mortgage, royalty or tribute, grant licences, assessments, options and other rights over and in any other manner deal with or dispose of the whole or any part of undertaking, property, assets, rights and effects of the company of such consideration as may be thought fit and in particular for stocks, shares, whether fully, or partly paid-up, or securities of any other company.

7. To pay for any rights or property, services acquired by the company and to remunerate any person, firm or body corporate for rendering services to the company either by cash payment or by allotment to him or them of shares or securities of the company as paid-up in full or in part or otherwise.

8. To lend and advance money, out of own surplus fund of the company not immediately required either with or without security and give credit to such person (including government) and upon such terms and conditions as the company may think fit but not amounting to banking business as defined under the banking regulation act, 1949.

9. To undertake commercial obligations, transactions and operations for achievement of the main objects of the company.

10. To guarantee the performance of any contract or obligations of and the payment of money unsecured or secured of any interest on, any debenture, debenture stock or securities of any company, corporation, firm or person in any case in which guarantee may be considered likely directly or indirectly to further the main objects of the company and in the above context to act as sureties.

11. To invest any money of the company out of own surplus fund of the company not immediately required in such investments as may be thought proper.

12. Subject to the provisions of law in force & the rules framed there-under & directives issued by R.B.I. for the time being, to receive money and borrow or raise money in such manner as the company shall think fit, and in particular by the issue of debentures or debenture stock perpetual or otherwise and to secure the payment of any money borrowed, raised or owing by mortgage, charge or lien upon all or any of the properties or assets of the company (both present and future), including its uncalled capital, and also by a similar mortgage, charge or lien to secure and guarantee the performance by the company or any other person or company as the case may be but not amounting to banking business as defined under the banking regulation act, 1949.

13. To draw, make, accept, endorse, discount, negotiate, execute and issue bills of exchange, promissory notes, bills of lading, warrants and other negotiable or transferable instrument or securities.

14. To apply for purchase or otherwise acquire and protect, prolong and renew in any part of the world, any patents, patent rights, brevets invention, trade-marks, designs, licences, protections, concessions

and the like conferring any exclusive or non-exclusive or limited right to their use or any secret or other information as to any invention, process or privilege which may seem capable of being used for any of the purpose of the company or the acquisition of which may seem calculated directly or indirectly to benefit the company and to use, exercise, develop, grant licenses or privileges in respect of or otherwise turn to accounts the property, rights and information acquired.

15. To expend money in experimenting on and testing and in improving or seeking to improve any patents, rights, invention, discoveries, process or information of the company or which the company may acquire or propose to acquire.

16. To establish, provide, maintain research centres and laboratories, training colleges, schools and other institutions for the training education and instruction of students and others who may desire to avail themselves of the same and to provide of the delivery and holding of lectures, demonstrations, exhibitions, classes, meetings and conferences in connection therewith.

17. To acquire and undertake all or any part of the business properties and liabilities of any person or company carrying on or proposing to carry on any business which this company is authorised to carry on or possessed of property, suitable for the purpose of the company or which can be carried on in conjunction therewith or which is capable of being conducted so as directly or indirectly to benefit the company in India or outside India.

18. To procure affiliation to or registration or recognition of the company in or under the laws of any place in or outside India and to open branches of the company at any place whether in India or outside India.

19. To form, incorporate or promote any company or companies, whether in India or outside India, having amongst its or their objects the acquisition of all or any of the assets or control or development of the company or any other object or objects which in the opinion of the company could or might directly or indirectly assist the company in the development of its properties or otherwise prove advantageous to the company and to pay all of the costs and expenses incurred in connection with any such promotion or incorporation and to remunerate any person or company in any manner it shall think fit for services rendered or to be rendered.

20. Subject to the provisions of the Companies Act, 2013 or any re-enactment thereof for the time being enforce, to amalgamate with company(s) or to enter into partnership or into any arrangement for sharing profits, union of interests, co-operation, joint venture or reciprocal concession with any person or persons, company or companies, carrying on or engaged, in or about to carry on or engage, in or being authorised to carry on or engage in any business or transaction which the company is authorised to carry on or engage in or which can carried on or in conjunction therewith or which is capable of being conducted so as directly or indirectly to benefit the company.

21. To enter in to any arrangements and to take all necessary or proper steps with government or with other authorities supreme, national, local, municipal or otherwise of any places in which the company may have interest and to carry on any negotiations or operations for the purpose of directly carrying out the objects of the company or effecting any modifications in the constitution of the company or furthering the interests of its members and to oppose any such steps taken by any other company, firm or person which may be considered likely directly or indirectly to prejudice the interests of the company or its members and to promote or assist the promotion, whether directly or indirectly, of any legislation which may appear to be in the interest of the company and to oppose and resist, whether directly or indirectly, and legislation which may seem disadvantageous to the company to obtain from and such government authority or any company by lawful means any charters, contracts, decrees, right, grants, loans, privileges or concessions which the company may think fit desirable to obtain and carry out, exercise and comply with any such arrangements, charters, decrees, rights, privileges or concessions.

22. To adopt such means of making known the products/services of the company as may seem expedient and in particular by advertising in the press or any other media by purchase, exhibition or reproduction of works of art or interest, by publication of books, picture and by granting prizes, awards and donations, or in such other manner as the company may deem desirable.

23. To undertake and execute any trust, the undertaking of which may seem to the company desirable, and either gratuitously, or otherwise and vest any real or personal property rights or interests acquired by or belonging to the company in any person or company on behalf of or for the benefit of the company and without any declared trust in favour of the company.

24. To apply the assets of the company in any way in or towards the extension, of any association, institution or fund in any way connected with any particular trade or business or with trade or commerce generally and particularly with the trade, including an association, institution or fund for the protection of the interest of masters, owners and employees against loss by bad debts, strikes, combinations, fire, accidents otherwise or for the benefit of any clerk, workman or others at any time employed by the company or any of its predecessors in the business or their families or dependents and whether or not in connection with other persons or classes of persons and in particular or friendly, co-operative and other societies, reading rooms, churches, chapels, temples, schools and hospitals and to grant gratuities, pensions and allowances and to contribute to any fund raised by public or local subscription for any purposes whatsoever.

25. To aid, any association, body or movement having for an object of the solution, settlement, or surmounting of industrial or labour problems or trouble or the promotion to industry or trade.

26. Subject to the provisions of the Companies Act, 2013 to subscribe or guarantee money for any nation, charitable, benevolent, public, general or useful object or for any exhibition subject to the compliance of central and state law.

27. To establish and maintain procure the establishment and maintenance of any contributory or non-contributory pension or superannuation funds for the benefit of and give or procure the giving of donations, gratuities, pension, allowances or emoluments to any person who is or was at any time in the employment or service of the company, or of any company which is a subsidiary of the company or is allied to or associated with the company or with any such subsidiary company, or who are or were at any time, directors or officers of the company or for any such other company as aforesaid, and the wives, widows, families and dependents of any such persons, and also establish and subsidiary and subscribe to any institutions, associations, clubs or funds considered to be for the benefit of or to advance the interest well-being of the company or of any such other company as aforesaid and make payments to or towards the insurance of any such person as aforesaid and do any of the matters aforesaid either alone or in conjunction with any such other company as aforesaid subject to the compliance of central and state laws.

28. Subject to the provisions of any law for the time being in force to distribute amongst the members in specie any property of the company, or any proceeds of sale or disposal of any property in the event of winding-up.

29. To undertake, carryout, promote and sponsor rural development including programme for promoting the social and economic welfare of or the upliftment of the people in any rural area and to include any expenditure or any programme of rural development and to assist in the execution and promotion thereof either directly or through an independent agency or in any other manner. Without prejudice to the generality of the foregoing "programme of rural development" shall also include any programme for promotion of the social and economic welfare of or the people in the any rural area which the directors consider as likely to promote and assist rural development and that the words "rural area" shall include such areas as may be regarded as rural area under the Income Tax Act, 1961, or any other law relating to rural development for the time being in force or as may be regarded by the directors

as rural areas and the directors may at their discretion in order to implement any of the above mentioned object or purposes transfer without consideration or at such fair or concessional value as the directors may think fit and divert the ownership of any property of the company to or in favour of any public or local body or authority or central or state government or any public institution or trust or fund as the directors may approve.

30. To undertake, carry out, promote and sponsor or assist any activity for the promotion and growth of the national economy and for discharging what directors consider to be social and moral responsibilities of the company to the public or any section of the public as also any activity which the directors consider likely to promote national welfare or social, economic or moral uplift of the people or any section of the people and in such manner and by such means as the directors may think fit and the directors may without prejudice to the generality of the foregoing, undertake, carry out, promote and sponsor any activity for publication of any books, literature, newspapers etc. or for organizing lecturers or seminars likely to advance these objects or for giving merit awards, scholarship or any other assistance to deserving students or other scholars or persons to enable them to pursue their studies or academic pursuits or researches and for establishing, conducting or assisting any institution, fund, trust etc. having anyone of the aforesaid objects or purposes transfer without consideration or at such fair or concessional value as the directors may think fit and divert the ownership of any property of the company to or in favour of any public or local body or authority or central or state government or any public institution or trust or fund as the directors may approve.

31. To buy, sell, purchase, repair, alter, improve, exchange, let out, import, export, and deal in all factories, works, plant & machinery, tools, utensils, appliances, apparatus, products, materials, substances, articles and things capable of being used in any business which this company is competent to carry on or which may seem capable of being profitable to deal with in connection therewith and to experiment with, render marketable and deal in all product or residual and by products incidental or to be obtained in any of the business carried on by the company and to do all such other things as may be deemed incidental or conducive to the attainment of the main objects of the company or any of them.

IV. The liability of the member(s) is limited and this liability is limited to the amount unpaid, if any, on the shares held by them.

V. **The Authorised Share Capital of the Company is Rs. 25,00,00,000 (Rupees Twenty-Five Crores) only divided into 2,00,00,000 (Two Crore) Equity shares of Rs.10/- (Rupees Ten) only each and 50,00,000 (Fifty Lakhs) Preference Shares of Rs. 10/- (Rupees Ten) only each, carrying such rights, privileges and conditions attached thereto as are approved by the Board and provided by the Articles of Association of the Company for the time being with power to increase and reduce the Capital of the Company and to divide the Shares in the Capital for the time being into several classes and to attach thereto respectively such preferential, deferred, qualified or special rights and to vary, modify or abrogate any such rights, privileges or conditions in such manner as may be provided by the Articles of Association of the Company and the Companies Act, 2013.”**
