Dear Sir/Madam,

This is in continuation to our earlier disclosures regarding the ongoing litigation matter involving the Company before the Hon'ble National Company Law Appellate Tribunal ("NCLAT"), New Delhi.

We wish to inform the stakeholders that the Hon'ble Supreme Court of India, in the matter titled *Cosmic CRF Limited vs. Myotic Trading Private Limited & Ors.* (Civil Appeal Diary No. 15468/2026), has vide its order dated 23rd March, 2026 (uploaded in the Hon'ble Supreme Court portal on 24th March, 2026), inter alia:

1. Condone the delay in filing the appeal and admitted the matter;
2. Issue notice to the respondents;
3. Permitted Dasti Service; and
4. Directed that the order earlier passed by the Hon'ble National Company Law Appellate Tribunal, Principal Bench, New Delhi dated 10th October, 2025, shall continue to operate till the next date of hearing.

The matter has been listed for further hearing in the week commencing 27th April, 2026.

This development ensures continuation of the legal position as it stood before the recent adverse observations and provides the Company an opportunity to present its case before the Hon'ble Supreme Court of India.

The Company remains committed to protecting the interests of all its stakeholders and will continue to take appropriate legal steps in this regard. Further updates shall be provided as and when there are material developments.
